



## TERMS AND CONDITIONS – WELCOME BONUS

### INTRODUCTION

1. **Xero Capital Markets Ltd** operating under the trading name Xero Markets is one of the organizations running from online trading and runs the spread as low as 0.0 pips for customers to generate their profits with no hidden charge. Xero Capital Markets Ltd, registered in Saint Vincent and The Grenadines, was licensed and authorized to carry on the business of dealing in securities as a principal by the Minister of Finance and Economic Management with company number 24273 IBC 2017 (hereinafter called the Company).
2. The **Welcome Bonus Terms and Conditions** are part of the Xero Capital Markets Ltd Client Agreement and the provisions herein are considered as an attachment to the Xero Capital Markets Ltd Client Agreement.

### CONDITIONS OF ELIGIBILITY

1. Subject to, and without prejudice to, the offer is available to clients who have satisfied the **Eligibility Criteria** for the offer as set out in the following sections hereinafter.
2. The **Welcome Bonus** will be offered by the Company from time to time to clients who open real trading account(s) with **Xero capital Markets Ltd**, in cases where such clients are referred to the Company via specific promotions and/or specific Partner/IB network.
3. Participation of intermediaries/related parties in the **Welcome Bonus** program is prohibited. If the registration and/or trading data of a participant in the Trading Bonus program corresponds with the registration and /or trading data information, **including but not limited to IP address**, of another participant in the **Welcome Bonus** program, the Company reserves the right to regard this matching as a reason for immediate disqualification.
4. Similarly, persons associated in any manner whatsoever with the Company and/or with the specific websites and/or social network sites on which the Company may be running from time to time on specific promotions, contests and/or surveys, are not allowed to participate in the offer of Trading Bonus.



## ELIGIBILITY CRITERIA

1. **Eligible Clients**, who meet the criteria set forth herein are able to receive the **Welcome Bonus of \$30** for new & existing clients that registered with the Company that meet all criteria stated in herein forth and clients are prohibited to deposit any amount to the Welcome Bonus account which the bonus is credited to.
2. Adding to, another criteria are stated in the Table as follow :

## SPECIFIC TERMS

1. The **Welcome Bonus** will be granted to all **Eligible Clients** and may be used for trading purpose only and cannot be withdrawn.
2. Client needs to create **Welcome Bonus account** to claim the **Welcome Bonus**. **Welcome Bonus** can be claimed by each **Eligible Clients** for **ONE-TIME** only.
3. Any withdrawal of funds and/or internal transfer between trading accounts will cause the removal of the **Welcome Bonus** entirely. Funds can only be transfer/withdraw after the account reach total profits of \$100.
4. The Company reserves the right, at its reasonable discretion :
  - a) to disqualify any client(s) from the **Welcome Bonus** program, who tampers or attempts to tamper with the operation of the **Welcome Bonus**, or breaches these terms and/or any other the Company's Agreement(s) and can result all of the account(s) will be nullified.
  - b) to discontinue the offering of **Welcome Bonus** to any clients and such clients may be informed via email or any relevant methods.



5. The Company reserves the right to alter, amend or terminate the **Welcome Bonus** or any aspect of it at any time. Prior notice of such changes will be informed to clients and the Company may post any such changes on its official website.
6. Any indication or suspicion, in the Company's reasonable discretion, of any form of arbitrage (including but not limited to risk free profiting), abuse, fraud, manipulation or any other form of deceitful activity, will nullify all previously credited **Welcome Bonus** and all transactions carried and/or profits or losses garnered therein. In these circumstances, the Company reserves the right, at its reasonable discretion to close all orders and annul all profits of such clients.
7. No partner's/IB's commissions are paid for trading with the Welcome Bonus.
8. The use of any **Autotrading Software**, including but not limited to Expert Advisor and/or cBot, are **prohibited**. The Company reserve the rights to remove completely, the bonus and all the profit generated, without prior notice to the clients.
9. If any of these terms were to be translated into a language other than English, then the English version of these terms shall prevail where there is an inconsistency.
